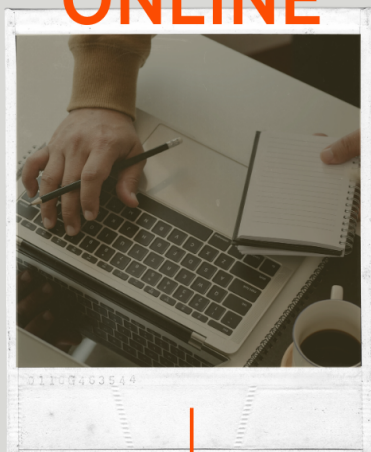

WHAT CAN I DO WITH A LAW DEGREE?



A Juris Doctorate (JD) degree is the highest education available in the legal profession in the United States and is considered the first professional graduate degree in law school.

This is typically a three-year, full time program. A bachelors degree is required for entry. International students may also consider a Master of Law (LLM) degree.

LLM degrees consist of between 20 and 26 academic credits, which take about one year of full-time study to complete. LLM degrees feature a more focused course of study in a topic or topics related to U.S law.
